#### 1. Welcome & Celebrations

- 2. Guest Tricia Stohr-Hunt, UR/ABTEL Chair Update: information related to the Uniform Performance Standards, Renewal Manual, and legislation that will impact initial licensure and licensure renewal.
- Tricia is completing her second term as Chair of ABTEL
- ABTEL Board asked VDOE to work towards developing a model evaluation system for teachers and administrators
- Phase I: weighting of standards
- Phase II: addition of culturally responsive and equitable practices standards (Standard 6)
- Draft of Phase II document went to Board of Education and there were lots of questions about the new Standard 6 (now there will be 8 standards instead of 7).
- Discussion focused on documentation of teacher performance and evaluation; the concern was that student surveys were not being used.
- This summer, Phase III the new language (Standard 6) will be added to standards for administrators/principals
- The Board will be sending out an RFP for development of a new/model evaluation system
- 270 points for re-licensure
- Discussions about renewal of licensure manual

- Adding a section on statutory requirements (trainings); added to this will be the new regulations to complete cultural competency training. Also, instruction in African-American history for social studies teachers. It is anticipated that statutory training in working with students with disabilities, differentiation, inclusivity, the role of the special education teacher, etc. will be signed (HB 2299). Statutory trainings will be assigned recert points.
- Final draft of licensure renewal manual will be presented to Board of Ed in April or May
- 3. Discussion interest in creating a VPEL Government Relations or Legislative Affairs Committee learning more about legislative processes, keeping VPEL informed, and representing VPEL interests. (Jaime, Sam, Kate)
- David Bailey is hired on a part-time basis by VACTE to track and inform them on legislation relevant to the organization.
- Might we want to join forces with VACTE? Is VPEL interested in pairing with VACTE?
- Can/should VPEL help fund David Bailey with VACTE as consultant?
- It's important to have subject-matter expertise informing policy and legislation. Concern expressed specifically surrounding unfunded mandates and unintended consequences.
- Jon Becker raised his hand as being interested in being involved. Jaime and Sam, as well.
- VASS has a comprehensive network approach to tracking and influencing legislation
- VPEC discusses legislation, but it's more information sharing than advocacy-oriented
- To be topic of discussion at VPEL-VACTE meeting this afternoon

- Looked at CAEP Assessment Standards and gave suggestions
- The folks at CAEP are listening and open to the suggestions
